

Internet Radio Recorder End Users License Agreement

CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS. This End User License Agreement (“EULA”) is a legal agreement between You and Fogware Publishing, Co. (“Fogware”) for the Internet Radio Recorder software program and documentation (“Software”).
